Discussion was held regarding potential requests to revisit the expansion of no wake zones on the Grand River.

Vugteveen made a motion supported by Kuck to approve Resolution 2020-06-14; A Resolution to Temporarily Relax Zoning and Land Use Requirements with no application fee required. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Berens to authorize the Treasurer to collect a stop payment fee for uncashed checks at her discretion. Motion carried.

Saddler made a motion supported by Vugteveen to; accept the apology of Fire Chief VanVelzen for not seeking Board authority prior to making a change in pay for fire department members, to confirm the fact that the Fire Chief does not have the authority to make changes in pay practices, to establish a liaison from the Board to the Fire Department to be determined at a later date and to acknowledge the Board's appreciation for the Fire Chief's efforts to keep his firefighters safe throughout the COVID-19 pandemic. Motion carried.

Hayward made a motion supported by Berens to accept the proposal from Diemer's Property Services for installing a new water line at the cemetery at a cost of \$1,893.50. Roll call vote was held with all members present voting yes. Motion carried.

Berens made a motion supported by Vugteveen to pay the bills. Motion carried.
