Vugteveen made a motion supported by Berens to approve the minutes of the October 14, 2020 meeting as presented. Roll call vote was taken with all members present voting yes. Motion carried.

Saddler made a motion supported by Hayward to approve the agenda with changes which removed the MERS Adoption Agreement and changed the order. Roll call vote was taken with all members present voting yes. Motion carried.

Roll call vote was taken with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Hayward to renew the Provident Accidental Death and Dismemberment Coverage for the Fire Department keeping the present plan and selecting the three year prepaid premium. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Berens to change the designees for calls from EPS Security for after-hours disturbances to: incoming Supervisor Frank Johnson as first call and Maintenance person Gary VandenBerg as second, and for Maintenance to be paid for a minimum of 1 hour if he is called in. Roll call vote was held with all members present voting yes. Motion carried.

Saddler made a motion supported by Berens to make Saddler and Hayward Co-Personnel Officer with the duties to be shared. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Hayward that the Township would pay the outstanding legal bills for the Peterson property escrow because the expenses occurred after the sale. Roll call vote was taken: Kuck: yes, Hayward: yes, Saddler: yes, Vugteveen: no, Berens: yes. Motion carried.

Saddler made a motion supported by Berens to pay Kuck for her attendance at the last Water Board Meeting. Roll call vote was taken with all members present voting yes. Motion carried.

Kuck made a motion supported by Vugteveen to appoint Hayward as Board Representative for the Water Board. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Hayward to table the Agreement for Contract Services with Brian Werschem. Roll call vote was held with all members present voting yes. Motion carried.
