The regular meeting of the Robinson Township Planning Commission was called to order at 7:00 PM at the Robinson Township Hall.

Non-Commission Member Inquiries and Questions

Supervisor Frank Johnson requested the following topics be investigated and reported upon by the Planning Commission.

- 1. The current prohibition on accessory buildings without a dwelling in Residential Zoning Districts. He reported he has had several public inquiries on this subject.
- 2. The current prohibition of in-law dwellings in addition to a primary residence. The inlaw dwelling should be reviewed both as attached and unattached from the primary dwelling.
- 3. The minimum required square footage for a dwelling. The current requirement prohibits mini-houses and restricts affordable housing options.

Chairperson Martinie stated these items would be placed on the agenda for review as soon as possible.

Travis Vugteveen reported the following from the Township Board.

- 1. The Township Board has approved a proposal from Fresh Coast Planning for Zoning Administrator services and is working through the details of the contract.
- 2. The Zoning Ordinance Text Amendment regarding Private Roads, Minimum Frontage, and Corner Lots, Sections 4.9B, 4.9A, and 4.22 respectively, was approved as Ordinance 2022-02-01.
- 3. It was decided to not pursue gypsy moth spraying.
- 4. Steve Young and Lydia Brown were both re-appointed for three year terms to the Planning Commission.
