

Minutes of the Regular Meeting
Robinson Township Board of Trustees
June 8, 2022 at 7:00 pm
12010 - 120th Ave, Grand Haven MI 49417

Present: Supervisor Frank Johnson, Treasurer Bonnie Hayward, Clerk Christine Saddler, Trustee Travis Vugteveen and Trustee Travis Bergman

Absent: None

Also present: Attorney Ron Bultje and ten members of the public.

The meeting was opened at 7:00 p.m.

The Pledge of Allegiance was recited. Supervisor Johnson gave the invocation.

Vugteveen made a motion supported by Bergman to approve the minutes from the May 11, 2022 meeting. Motion carried.

Hayward made a motion supported by Saddler to approve the agenda with the addition of Park Board presentation as the first item and addition of "any and all" as #6. Motion carried.

Supervisor Johnson gave his opening remarks.

County Commissioner Greg DeJong gave an Ottawa County update. Ready to break ground at the Fillmore Complex on a new Family Justice Center.

Mary Twa and Jenny Sias from the Park Board made a presentation to the Board. The ½ Court Basketball court is completed, the tennis court is being cleaned up and will have a pickleball court marked out with tape. An additional fence has been added to south side of the baseball field. Future projects on wish list include mapping the park, fitness equipment for the walking trails and the playground, replacing the scoreboard shed, bleachers, paving the driveway. The board asked for additional information on proposed projects.

Vugteveen made a motion supported by Johnson to approve the Class B Earth Change renewals for the South Cedar, 108th and Clark Farm sites based on the recommendations made by the planning commission and the Zoning Administrator's report. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Hayward to approve the proposal from TDS for the line conversion choosing the 24-month option. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Johnson to reappoint Breanna Fowler to the Zoning Board of Appeals for the three-year term expiring January 2025. Motion carried.

Johnson made a motion supported by Saddler to accept the proposal from Eisen AV for security cameras in the parking lot, selecting Option 1. This will provide security for the drop box. Roll call vote was held with all members present voting yes. Motion carried.

Hayward made a motion supported by Vugteveen to approve the purchase of 5 sets of turn-out gear for the fire department from Dinges at a cost of \$15, 218.15 plus shipping. A roll call vote was held with all members present voting yes. Motion carried.

Discussion was held regarding the street light at 136th and Green. Supervisor Johnson is to investigate its status.

Discussion was held regarding a home that was built without permits and was the subject of a previous lawsuit which is now for sale. The consensus of the Board was to have Attorney Bultje draft a letter that essentially states that the Township has not approved any of the construction. This letter could be recorded and become part of the property's record.

Johnson made a motion supported by Bergman to pay the bills. Motion carried.

Reports are on file.

Motion was made by Vugteveen and supported by Bergman to adjourn the meeting at 8:26 pm. Motion carried.
