

Minutes of the Regular Meeting  
Robinson Township Board of Trustees  
October 12, 2022 at 7:00 pm

Present: Supervisor Frank Johnson, Treasurer Bonnie Hayward, Clerk Christine Saddler and Trustee Travis Vugteveen.

Absent: Trustee Travis Bergman.

Also present: Attorney Ron Bultje and eight members of the public.

The meeting was opened at 7:00 p.m.

The Pledge of Allegiance was recited. Supervisor Johnson gave the invocation with a moment of silence to honor former Deputy Clerk Jenny Sias who had recently passed.

Vugteveen made a motion supported by Hayward to approve the minutes of the September 14, 2022 Regular Board Meeting. Motion carried.

Hayward made a motion supported by Vugteveen to approve the agenda with the removal of the brining agenda item. Motion carried.

Supervisor Johnson gave his opening remarks.

Chris VanHekken from the North Ottawa Recreation Authority (NORA) organization gave a presentation on what programs they provide to the community and why they are hoping to have the millage that is on the November general election ballot approved.

Haward made a motion supported by Vugteveen to approve the purchase of an additional bleacher for the south soccer field from Sideline Sports and four benches from Game time at a total cost not to exceed \$13,000. Roll call vote was held with all members present voting yes. Bergman absent. Motion carried.

Hayward made a motion supported by Saddler to have Attorney Bultje's office update the zoning ordinance to incorporate all of the amendments to recodify it. Roll call vote was held with all members present voting yes. Berman absent. Motion carried.

Hayward made a motion supported by Vugteveen to set the holiday closures for the office as December 26 and January 2. Motion carried.

Saddler made a motion supported by Vugteveen to pass Fire Fund Budget Resolution 2022-10-~~13~~ 14. Roll call vote was held with all member present voting yes. Bergman absent. Motion carried.

Hayward made a motion support by Vugteveen to pass General Fund Budget Resolution 2022-10-~~14~~ 15. Roll call vote was held with all members present voting yes. Bergman absent. Motion carried.

Haward made a motion supported by Vugteveen to approve the proposal from Burnham and Flower for the renewal of insurance coverage for the 2022-2023 year adding the option to increase the non-

monetary defense coverage at a cost of \$250. Roll call vote was held with all members present voting yes. Bergman absent. Motion carried.

Haward made a motion supported by Johnson to approve quote #2278 from Diemer's Property Services LLC for mole patrol service at a cost of \$1,750. Roll call vote was held with all members present voting yes. Bergman absent. Motion carried.

Public comment time was held: Topics included supervisors' pictures in board room, Fox and Hen Winery, and an inquiry on the possibility of 124<sup>th</sup> being paved.

A checklist of needed items for submittal of commercial projects is being developed.

Hayward made a motion supported by Vugteveen to approve the donation of the Fire Department's old Holmatro tools to the Crystal Valley Fire Department. Motion carried.

Vugteveen made a motion supported by Hayward to pay the bills. Motion carried.

Reports are on file.

Vugteveen made a motion supported by Hayward to adjourn the meeting at 8:54 pm. Motion carried.
