An invocation was offered by Berens, followed by the Pledge of Allegiance.

Opening remarks by Supervisor Mulligan.

Berens made a motion to approve the May Minutes. Supported by Hayward. The motion carried.

Hayward made a motion to approve the agenda with one change: Commissioner Greg DeJong would not be present. Vugteveen seconded the motion and it was approved.

Hayward made a motion to rescind the lot merger agreement with Jim Angel, recorded on 04/06/1994. Vugteveen supported the motion and a roll call vote was taken. All members voted aye. The motion was approved.

Vugteveen made a motion to approve Andrew Berens as a new hire to the Fire Dept. Frye supported the motion and it was approved.

Berens made a motion to untable the street light issue for M-231 and Lincoln and M-231 and M-45. Vugteveen supported the motion and it was approved.

After discussion it was decided that more information was needed and Hayward made a motion to table the issue until such information was received. Berens seconded the motion and it was approved.

Hayward made a motion to untable Phase 2 of the Winans St. Project. Vugteveen supported the motion and it was approved.

Vugteveen made a motion to approve Phase 2 of the Winans St. project. Hayward seconded the motion. A roll call vote was taken with all members voting aye. The motion carried.

Berens made a motion to approve Nancy Esnaola to a new 3 year term to the Park Board. Vugteveen supported the motion and it was approved.

Berens made a motion to approve the two Grant Agreements with the G.H. Community Foundation. Hayward supported the motion and a roll call vote was taken with all members voting aye. The motion carried.

Berens made a motion to move forward with the two grants to improve the ball fields. Hayward supported the motion. A roll call vote was taken with all members voting aye. The motion was approved.

Hayward made a motion to approve a \$9000.00 grant match for the park. Berens supported the motion and it was approved unanimously by roll call vote.

Stille-Mulligan made a motion to approve the new FOIA Policy Revisions effective 07/01/2015. Frye supported the motion. A roll call vote was taken with all members voting aye. The motion carried.

A motion was made by Vugteveen to approve Resolution # 2015-06-11 designating the Deputy Clerk as FOIA Coordinator. Hayward supported the motion. A roll call vote was taken. All members voted aye. The motion carried.

Berens made a motion to approve the hiring of a temporary assistant to the Treasurer as her deputy will not be working for some time this summer. Vugteveen supported the motion and it was approved.
