

**MINUTES OF THE REGULAR BOARD MEETING

THE MEETING WAS OPENED BY SUPERVISOR MULLIGAN. TRUSTEE KUYERS GAVE THE INVOCATION THAT WAS FOLLOWED BY THE PLEDGE OF ALLEGIANCE.

BERENS MADE A MOTION TO APPROVE THE AUGUST 2010 MINUTES. KUYERS SUPPORTED THE MOTION AND THE MOTION PASSED.

KUYERS MADE A MOTION TO CHANGE THE AGENDA AND MOVE ITEM #7 TO #1 AND ITEM #6 TO #2. BERENS SUPPORTED THE MOTION AND THE MOTION CARRIED.

SUPERVISOR MULLIGAN GAVE THE OPENING REMARKS.

KUYERS MADE A MOTION TO PLACE THE HISTORICAL BELL IN THE TOWNSHIP PARK AND TO HAVE THE CLAPPER LOCKED TO AVOID ACCIDENTS. FRYE SUPPORTED THE MOTION AND THE MOTION WAS APPROVED.

RON BULTJE STATED THAT HE WAS DRAWING UP A DRAFT OF AN AGREEMENT CONCERNING THE HORTON PROPERTY AND THAT IT WAS NOT FINISHED YET.

KUYERS MADE A MOTION TO APPROVE THE PURCHASE OF A WEB FILTERING PROGRAM NOT TO EXCEED \$1000.00. BERENS SECONDED THE MOTION. A ROLL CALL VOTE WAS TAKEN. AYES: KUYERS, BERENS, HAYWARD, FRYE AND MULLIGAN. NAYS: NONE. THE MOTION WAS APPROVED.

BERENS MADE A MOTION TO APPROVE THE 2010 HOLIDAY HOURS. CLOSING ALL DAY 11/25, 11/26, 12/24, 12/27, 12/30 AND 12/31. REOPENING ON JANUARY THIRD. THE MOTION WAS SUPPORTED BY FRYE AND WAS APPROVED.

FRYE MADE A MOTION TO APPROVE THE APPOINTMENT OF JOHN KUYERS TO THE PLANNING COMMISSION. BERENS SECONDED THE MOTION AND THE MOTION CARRIED.

HAYWARD MADE A MOTION TO APPOINT DEPUTY CLERK CHRIS SADDLER TO THE AMBULANCE COMMITTEE. KUYERS SUPPORTED THE MOTION AND IT WAS APPROVED.

FRYE MADE A MOTION TO APPROVE THE SITE PLAN OF LIFETREE COMMUNITY CHURCH AS RECOMMENDED BY THE PLANNING COMMISSION, WITH ALL PLANNING COMMISSION COMPLIANCE RECOMMENDATIONS. BERENS SECONDED THE MOTION AND THE MOTION CARRIED.

BERENS MADE A MOTION TO APPROVE THE S&M GRAVEL EARTH CHANGE PERMIT AS PER THE PC RECOMMENDATION. FRYE SUPPORTED THE MOTION AND IT WAS APPROVED.

DISCUSSIONS WERE HELD CONCERNING MEETING TIMES. THE CONSENSUS WAS TO HAVE THE REGULARLY SCHEDULED WORKSHOPS IF WE NEED THE ATTORNEY FOR CONSULTATION AND CONTINUE REGULAR THIRD MONDAY OF THE MONTH MEETINGS UNLESS CIRCUMSTANCES WARRANT A CHANGE.

THE POSSIBILITY OF A FUTURE SAND VOLLEY BALL COURT IN THE TOWNSHIP PARK WAS DISCUSSED.

KUYERS MADE A MOTION TO PAY THE BILLS. BERENS SUPPORTED THE MOTION AND IT CARRIED.

KUYERS MADE A MOTION SUPPORTED BY FRYE TO ADJOURN. IT WAS APPROVED AND THE MEETING ADJOURNED AT 8:20 P.M.
