THE MEETING WAS OPENED BY SUPERVISOR MULLIGAN. AN INVOCATION WAS GIVEN BY BERNICE BERENS THAT WAS FOLLOWED BY THE PLEDGE OF ALLEGIANCE.

BERENS MADE A MOTION TO APPROVE THE NOVEMBER MINUTES. HAYWARD SECONDED THE MOTION AND IT WAS APPROVED.

HARRISON BODRID GAVE A PRESENTATION OF THE EAGLE SCOUT PROJECT HE WAS WORKING ON FOR ROBINSON TOWNSHIP. FRYE MADE A MOTION TO ACCEPT THE PROJECT CONSISTING OF PLANS AND MATERIALS FOR A SAND VOLLEYBALL COURT IN THE TOWNSHIP PARK. BERENS SUPPORTED THE MOTION AND THE MOTION WAS APPROVED.
